has been entitled to exercise **activity of a mountain guide** on the basis of business license with subject of business **"Mountain guide services"** within the meaning of the Act No. 455/1991 Coll. On Trades (Trade Act) as amended since 11.02.2016 up to the present. Operation of the trade was interrupted on 11.02.2016 at the request of the entrepreneur. Applicant carried out above mentioned activity demonstrably at the territory of the Czech Republic in a position of an employee in the period from 16.07.2007 to 28.09.2012 (evidenced by employer's confirmation Vít Novák, ADRENALIN SPORT, ČSLA 405, 391 11 Planá nad Lužnicí, company ID 632 65 231), i.e. altogether 5 years and 2 months.

Furthermore, the Ministry of Industry and Trade certifies that the applicant has been entitled to exercise activity **providing physical education and sports services in the field of swimming, skiing, athletics and canoeing** on the basis of business license with subject of business **"Providing physical education and sports services in the field of swimming, skiing, athletics and canoeing"** within the meaning of the Act No. 455/1991 Coll. On Trades (Trade Act) as amended since 11.02.2016 up to the present. Operation of the trade was interrupted on 11.02.2016 at the request of the entrepreneur.

Furthermore, the Ministry of Industry and Trade certifies that exercise of activities **“Mountain guide services”** and **“Providing physical education and sports services in the field of sport”** in the form of business in the mode of the Trade Act is a regulated activity in the Czech Republic, that the applicant completed educational programme of retraining course “Mountain guide” for work activity “Mountain guide” (evidenced by the certificate of retraining issued by the Czech Association of Mountain Guides, ČSLA 405, 391 11 Planá nad Lužnicí, in Prague dated 31.01.2008), that the applicant completed education and training in educational facilities under the Higher Education Act in the field of study “Training Teachers of General Subjects (Physical Education – Civics)”, evidenced by the diploma issued by Pedagogical Faculty of the University of Ostrava and that he fulfills the conditions for the exercise of regulated activities given by the Trade Act.

Furthermore, the Ministry of Industry and Trade certifies that the applicant fulfills the requirement of integrity for the exercise of activity under section 6 paragraph 1 letter b) of the Trade Act, that he does not have any record of fines in the Trade Register in connection with business at the territory of the Czech Republic, that the exercise of activity was not forbidden to him or stopped, and there was not any decision on bankruptcy issued against him and there was no record about rejecting the proposal for bankruptcy because his assets will not be sufficient to cover the costs of insolvency proceedings.
